A message from President Matthew B. Pagels



Nya:wëh sgë:nö' gagwe:göh,

I hope everyone had a wonderful Mother's Day. We should honor the contribution of mothers everyday as the protectors and guardians of our future. We appreciate and respect everything you do for our children.

This month I'd like to acknowledge May 5th as the National Day of Awareness for Missing and Murdered Indigenous Women and Girls. The Crime Victim Services program coordinated many events to bring awareness to these crimes. Staggering statistics of missing/murdered mothers, daughters, sisters across the United States sparked the enactment of this day of recognition. In fact, Native American Women are more than twice as likely

to experience violence than any other demographic. Please keep families who have lost loved ones in your thoughts and prayers.

The Nation recently notified the City of Olean of our intent to take legal action for the repeated discharges from the City's wastewater treatment plant into the Ohi:yo'. This waterway is a very precious resource to our Nation. It is part of our heritage and we will not allow anyone to be at risk. Many families spend time in and around the river throughout the summer. We must protect this important resource and ask our neighbors to be more mindful of this situation and take-action to correct this issue.

If this isn't rectified we may need to pursue legal action under the Clean Water Act, as having safe and clean water is a basic human right. Everyone along the Ohi:yo' deserves to be protected.

I had hoped we could start limiting our COVID conversation, but as you may know we are seeing an increase in COVID numbers around our communities. There were 33 active cases as of May 5th within our health centers. The new variant is more contagious as the previous OMICRON strain. Please continue to practice COVID protocol and get tested if you experience symptoms. If you test positive for the virus please follow the public health

recommendations for isolating and masking to help reduce the spread.

Test appointments are still available to enrolled Seneca members through Blue Stone - Monday through Friday between 9:00-3:00 pm at Seneca Fire Station #1 by appointment in Cattaraugus and at Seneca Fire Station East Loop Rd in Allegany. To make an appointment call 716-220-2440. Photo ID is required and do not eat, drink or smoke for at least 1 hour prior to testing. Contact Mike Gates, Emergency Management Director for specific questions at 716-244-0820 or at mike.gates@sni.org.

Also, COVID vaccines and boosters are still available through Seneca Health System for all eligible individuals and age groups. Please contact Cattaraugus health at 716-532-5582 and LR John at 716-945-5894 for appointments. Please continue to take all precautions to help stifle this disease.

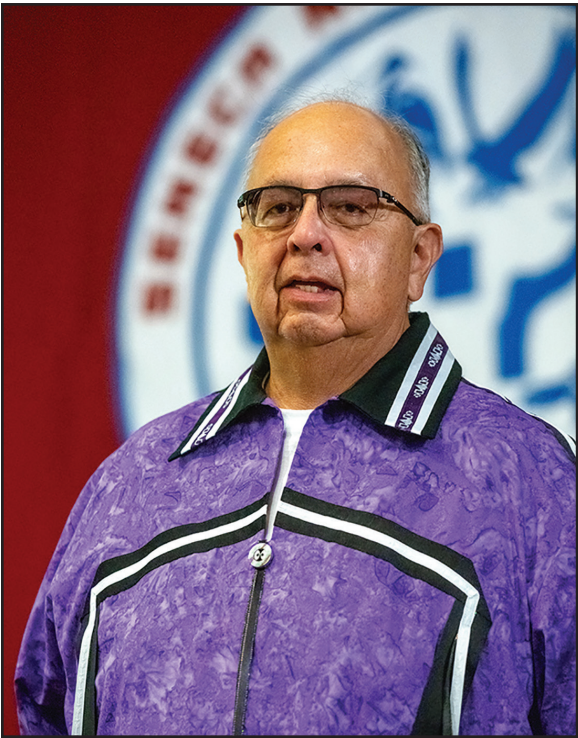

Greetings,

I've been enjoying getting outside and taking care of a few yard projects, since the weather is finally warming up. Also enjoying catching some lacrosse games. Time to get all the gardens ready for planting. I hope everyone enjoys these warmer days!

The Seneca Nation was recently awarded two grants from the Built to Play Skatepark grant fund. The grants were secured by our Seneca Nation Department of Transportation, working cooperatively with the Community Planning & Development Department. The grants

will either fully, or in part, pay for the permanent concrete skate parks on the Allegany and Cattaraugus territories. In Cattaraugus, the skate park will be located on the site of the Cattaraugus Community Center; while the Allegany site is yet to be determined. Now that the award has been announced, the Nation will host two community meetings to seek community input: Allegany community meeting will be held on Tuesday, May 17th, 2022, at the Allegany Community Center at 6:00pm; and the Cattaraugus community meeting will be held on Wednesday, May 18th, 2022, at 6:00pm. The unofficial beginning of summer is generally marked by Memorial Day, which occurs on the last Monday of May. This day is set aside as a traditional day to remember fallen service members and to decorate their graves with flags and flowers. This is a busy time for members of Iroquois Post #1587, on the Cattaraugus territory. The Memorial Day remembrances begin on Sunday, May 22nd, 2022, from 10am to 3pm and continues on the 23rd, 24th and 25th, until all graves are decorated, starting each day at 10am. On Sunday, May 29th, there is a sunrise service scheduled to start at Good Shepard Church, in Irving, at 8:30am. Additional salute honorings will follow at: Newtown Cemetery in Lawtons,

Pinewoods Cemetery in Pinewoods and Indian Hill Cemetery up Indian Hill. The final salute will take place at the SNI Cemetery at 11am. Iroquois Post #1587 and the Nation invite our community members to attend the Memorial Day ceremony on Monday, May 30th, 2022, at 11:00am, at the Seneca Allegany Administration Building (SAAB), as they pay tribute to and honor our Seneca warriors whom have paid the ultimate sacrifice. If you would like to sign up for Direct Deposit of your Annuity and/or Elders Check, you will have to complete the form. The form is available on the web at www.sni.org under Documents/ Clerk’s Office / Direct Deposit forms or at the Clerk’s Office.

- All direct deposit forms MUST have attached a voided check or deposit slip (start-up checks will NOT be accepted).
- Members must be at least 18 years old to sign up for Direct Deposit
- Minors are NOT eligible for Direct Deposit

If you receive direct deposit, it is your responsibility to keep your address updated with the Clerk’s Office.

The Seneca Nation is looking for two (2) interested individuals to submit their qualifications to serve as a member of the Board of Directors of the Seneca Gaming Corporation. The Corporation Board currently has a vacant seat which expires in 2024.

Pursuant to the Charter adopted by the Nation's Council, every director shall meet the following minimum qualifications:

- must be at least 21 years of age;
- must have earned at least a high school diploma or equivalent;
- must not have been convicted of a Felony, as defined under the Indian Major Crimes Act (18 U.S.C. §1153);
- must not be an immediate family member, defined as, husband/wife (including common law relationships), child/grandchild, mother/father, brother/sister, aunt/uncle, first cousin, niece/nephew, grandparent, mother-/father-in-law, or brother-/sister-in-law, of any person reporting directly to the Board;
- must be certified by the Seneca Gaming Authority as having met the substantive standards necessary to obtain a license from the Authority if such candidate were a "Class III Gaming Key Employee" as that term is used in the Nation's Class III Gaming Ordinance;
- no Elected Nation Official may serve on the Board; and
- no Company employee, nor any person with an economic interest in the Company's activities may serve on the Board.

INSTRUCTIONS TO APPLY

Interested individuals are invited to submit a letter of interest and a résumé to the Nation's Clerk and a complete licensing application to the Seneca Gaming Authority Licensing Manager as set forth below. The Council plans to schedule interviews once the SGA has completed its background check and both the SGA and the Nation's Clerk have certified that the individual is an eligible candidate for the director position.

Candidates are strongly encouraged to submit their materials to both the Nation and the Seneca Gaming Authority as soon as possible, in order to provide sufficient time for the background check and certification process to occur. The Seneca Nation of Indians is seeking interested individuals to submit their qualifications to serve as a member of the Management Committee of Seneca Holdings, LLC. The company's Management Committee currently has **one vacancy** for appointment.

Pursuant to the Charter adopted by the Nation's Council, every Management Committee member shall meet the following minimum qualifications:

The company’s sportsbook betting counters are open daily and self-service kiosks are available 24/7. Since opening in late 2019, the sportsbook lounges have exceeded our expectations, and the response and excitement from our guests have been tremendous.

Since New York licensed operators for mobile and online sports wagering earlier this year, most of us have seen the barrage of advertisements from those companies. We understand that this new competition could impact our revenues and operations. However, the New York bid process did

allow us to secure a revenue sharing agreement with one of the strongest consortiums bidding for New York licenses, consisting of FanDuel, DraftKings, BetMGM and Bally Bet. Under our agreement, SGC will receive payments based on the revenue generated by this consortium. It is important to note that our business agreement is with these four companies. It is in no way an agreement with New York State, nor does it obligate us to New York in any way.

It is also important to note that, although we will receive revenue share payments under this business agreement, these companies remain our competition. SGC continues to encourage our guests to come wager with us in a fun, social environment, where they can interact with other sports betting fans and enjoy all the games in real time on dozens of screens. Additionally, we pay winnings in cash instantly and believe this - along with all of our other gaming options and resort amenities - will continue to fuel our Seneca Sports Lounges for future success.

In regard to SGC’s ability to provide mobile and online gaming outside Nation Territory, federal law is currently the most significant obstacle for the Nation and all of Indian Country to participate in this space. Simply put, federal law currently limits SGC’s ability to take bets from patrons who are physically located off-territory. The issue of off-territory mobile and online sports betting is currently subject to legal challenges in Florida, and we are closely monitoring those developments. Legislative fixes have also been proposed at the federal level, but have not yet been successful. SGC will continue to plan and position ourselves to take advantage of other gaming opportunities as they become available to us.

Seneca Nation Puts City Of Olean On Notice For Clean Water Act Violations

Notice Letter Triggers 60-Day Waiting Period For City To Rectify Ongoing Dangerous Discharges from Waste Water Treatment Plant



ALLEGANY TERRITORY, SALAMANCA, N.Y. – Continuing its long history of protecting the health and safety of its citizens and defending Mother Earth from environmental harm, the Seneca Nation recently notified the City of Olean of its intent to take legal action to address a dangerous pattern of harmful discharges from the City’s waste water treatment plant into the Ohi:yo’ (Allegheny River), which runs through the Nation’s Allegany Territory.

The Nation sent a notice of intent to initiate civil action against the City pursuant to Section 301 of the Clean Water Act, 33 U.S.C. § 1311(a) for discharging pollutants, including enterococci, among other things, in excess of the effluent limits on a regular and continuing basis. According to the Nation’s letter, the discharges are either still occurring or are likely to occur in the future.

“Ohi:yo’ is part of our Nation, part of our lives and part of our heritage, and we will not allow our people and our future generations to be put at risk,” said Seneca Nation President Matthew Pagels. “Our

connection to and dependence on our natural resources and important life-giving and life-sustaining resources like Ohi:yo’ must be protected from harmful actions. We will not turn a blind eye to this situation, and we demand our neighbors do the right thing and protect the river and the people impacted by their actions.”

The City operates the Olean Waste Water Treatment Plant at 174 S. 19th Street. The plant discharges sewage, stormwater and/or wastewater into the river pursuant to a State Pollutant Discharge Elimination System permit. The most recent discharge in excess of the limits specified by the permit occurred on March 7, 2022. On that date, approximately 48,000 gallons of untreated sewage was discharged into the Allegany River from a sewage lift station located at 411 S. 4th Street, Olean, New York. Effluent from the discharge contained 310 CFU/100mL of enterococci, which exceeds the reporting limit of 61 CFU/mL. In addition, E. coli, fecal coliform and nitrates were detected in effluent samples.

Because of the chronic nature of the City’s violation of its discharge permit, the Nation believes it is more than reasonable that the illegal discharges will continue, impacting the health, safety and well-being of countless people who utilize and

depend upon the river, which is a source of drinking water for millions of people, from the Southern Tier of New York down to Pittsburgh.

The Seneca Nation intends to sue for all Clean Water Act violations and is seeking civil penalties for any additional violations discovered in the future – including during the course of litigation – as well as any that might occur subsequent to the notice delivered to the City. In addition, the Nation intends to seek injunctive and remedial relief to halt the continuing illegal discharges, as well as costs, attorney and expert witness fees, and such additional relief as the court determines may be appropriate.

In 2021, the Nation took similar action against Clean Water Act violations by the Village of Portville to address persistent sewage discharge violations. The Nation was also a vocal opponent of a controversial proposed wastewater treatment facility for fracking water at the headwaters of the river near Coudersport, Pennsylvania in 2018. Plans for the facility were voted down.

“Clean, safe water is a basic human right, which should never be put in question,” President Pagels said. “The river must be preserved so that it can sustain lives in the Seneca Nation and in neighboring communities for generations to come.”

NOTICE - Lampricide Application

Allegany - Environmental Protection

US Fish & Wildlife will be working with SNI Fish & Wildlife to treat Cattaraugus Creek with lampricide from May 24th through June 2nd in order to control sea lamprey. Sea lamprey is a parasitic fish native to the northern and western Atlantic Ocean that has invaded the Great lakes and their watersheds. Lamprey have a disc-shaped, suction-cup mouth, ringed with sharp, horny teeth that latch onto fish and feed on their blood and body fluids. One lamprey kills about 40 pounds of fish every year.

The application of lampricide requires a dye to mark where the product is flowing. So if you are seeing yellowish color streak in the waters of Cattaraugus Creek during this time, it is completely normal. Studies have shown that no adverse effects result from contact with lampricides and the water is still safe for recreation.

New Queen Bee Colonies Arrive at Gakwi:yo:h Farms

With the arrival of 30 NEW queen bee colonies, staff at Gakwi:yo:h Farms have been busy! On the morning of Saturday, April 23rd, youth workers Nathan Warrior and Dustin Mohawk volunteered to assist with unloading the bees to their new homes at 7am sharp. Conner - Gakwi:yo:h Farms Laborer, and Jack – Gakwi:yo:h Farms Agriculture Coordinator, explained how to maintain, care for and transport the beehive boxes and informed them of what roles the queens, worker bees and drones jobs are in each colony. Nathan and Dustin loved the experience and are excited to come back and work with the farm again.

Prior to the arrival of these new colonies, Gakwi:yo:h Farms had 24 hives on site, with the addition of these 30 new hives, that brings their total to 54 on-site hives.

When asked if this is the best time of year to transport the bees, Gerry Fisher, Gakwi:yo:h Farms Project Manager said “You can transport them any time but the best time to transport bees is in the evening, when the bees are back in the hive or early in the morning. If they are traveling via transport for a long distance, their entrance should be blocked and they need proper ventilation so the hive does not overheat. Therefore the time of day is very important regarding transport, not the time of year.”

Gerry also noted that the staff at the farm is **excited to launch the sale of honey this season at Gakwi:yo:h Farms Market! Stay tuned!**

Memorial Day is a time to remember and pay tribute to our fallen military service members who have joined the great spirit Army of Warriors in Skyworld. Many of our community members across both Territories will observe this solemn occasion by visiting cemetery sites and decorate Veterans’ graves with flags and

flowers. In fact, Memorial Day started as Decoration Day where the tradition of adorning service member graves with flags and flowers originated at Waterloo, New York. (The town was officially declared the birthplace of Memorial Day in 1966.)

After the First World War, Decoration Day was renamed Memorial Day and became a time to honor the lives lost in all armed conflicts, not just the Civil War. In 1968, Congress passes a law declaring Memorial Day a federal holiday to be observed each year on the last Monday of May.

Seneca Nation Awarded Two “Built to Play” Skatepark Grants

Cattaraugus Territory, Seneca Nation – The Seneca Nation announced it will soon be home to two new concrete skateparks as the result of two distinct grant awards from the Built to Play Skatepark Grant fund. These awards, secured by the Seneca Nation Department of Transportation (SNIDOT) in cooperation with the Community Planning & Development Department (CPDD), will provide for permanent concrete skateparks on the Allegany and Cattaraugus Territories of the Seneca Nation. The newly funded parks will be located at the Cattaraugus Community Center in Irving, NY, while a second park location will be determined through community meetings and fundraising efforts on the Allegany Territory.

“As a Nation focused on our seventh generation, we put a tremendous amount of our heart and soul into our Seneca youth. We can all easily recognize the importance of access to engaging outdoor activities. Since 2019, community members have been pursuing a Built to Play Skatepark Grant from The Skatepark Project. Today’s announcement is a win-win for skateboarders and BMX riders in our communities, as well as our leaders here today. This administration is thrilled to see this vision come to fruition,” said Seneca Nation President Matthew Pagels.



routinely provides funding for those communities that wish to work to develop them,” said Trevor Staples, Built to Play Skatepark Manager.

Following this announcement, fundraising will begin immediately to reach the \$250,000 goal set for the Seneca Skatepark located on the Allegany Territory in Salamanca, NY. These funds must be finalized by January 10, 2023 in order to proceed. Funds allocated for the Seneca Skatepark on the Cattaraugus Territory will fully cover the cost of construction. Construction is anticipated to be complete by the Fall of 2022 at the Cattaraugus Territory Seneca Skatepark, while construction will wrap up in the Fall 2023 at the Allegany location.

“We are committed to creating a fun and safe place where our youth can get involved with skateboarding and help build healthy and active lifestyles. These skateparks will be an exciting addition to our communities,” said Seneca Nation Tribal Councillor William “Billy” Canella.

In order to move this project from concept to reality, the Seneca Nation will host two community input meetings in May 2022. The first meeting will be held on May 17 at the Allegany Community Center (ACC) on the Allegany Territory at 6:00 p.m. The second will be held the following evening, May 18, at the Cattaraugus Community Center (CCC) in Irving, NY, also at 6:00 p.m.





The Longhouse build at the Onöhsagwë:de' Cultural Center is underway!

SALAMANCA, NY- The Onöhsagwë:de' Cultural Center is building a Longhouse on the Ohi:yo' Territory. The project will be headed up by Rod Pierce, Seneca. Pierce and Carson Waterman built the first Longhouse in the former Seneca-Iroquois Museum located on Broad Street back in the 1970's. On April 26th, Pierce, Darcy Scott, Bucky Bray, Blaine Tallchief, Chris Tallchief and Keith Spruce raised a Hiawatha Belt flag prior to inserting the main posts for the structure.



to extend the structure if and when needed. Traditionally, the lower level was for sleeping and the top level was used for storage. Each family had their own section across the Longhouse, which could be as long as 200 feet depending on the size of the family. Elm trees are used for the frame and the bark is wrapped around the outside as protection or siding.

Once completed, the Longhouse will serve as a center for the Hodinöshö:ni' community in an effort to bring back traditions and give opportunities to educate visitors about our culture. In our language, Hodinöshö:ni' means "People of the Longhouse." Our Longhouse is not only a dwelling, it is also represented as a symbolic structure for all Hodinöshö:ni' Nations under one roof as one family.

We are known as "Keepers of the Western Door," Mohawks are "Keepers

of the Eastern Door" and Onondagas are "Keepers of the Fire," where the central fire continues to burn. The Tuscarora Nation, the Cayuga Nation and the Onieda Nation are considered our "Younger Brothers" and occupy Territories between the "Elder Brothers;" Senecas, Mohawks and Onondagas across New York State. These Nations shaped the Iroquois Confederacy after forming an alliance and burying their weapons under the Great Tree of Peace inspired by the Peacemaker's vision.

Hayden Haynes, Business Manager, hopes to see the Longhouse come to life through the community, "this structure is for the community - by the community. We hope to see everyone come together to get the project done and hope to hold socials and cultural activities in the future."

The structure will emulate the traditional rustic Seneca dwelling from the precolonial period with two doors on each end, smoke holes for fires and dual level bunks. The 20'x40' build is what would have been the size of a storage shed for harvesting meat and produce. Pierce has said there is room

The crew intends to make significant progress over the next couple months and is seeking volunteers to make this goal a reality. If you like to help, please call the museum at 716-945- 1760.

A coloring sheet was shared with the community and displayed at the event. Staff also handed out lawn signs for community members to display in solidarity and awareness.

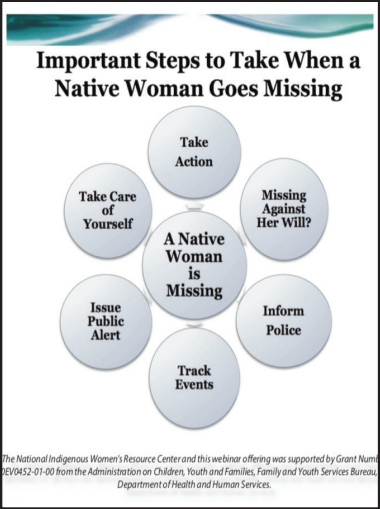

On May 5th, Seneca Nation Executives, Councillors and employees wore red in observance of Missing and Murdered Indigenous Women's Day of Awareness.

"Countless Indigenous women, mothers, daughters and sisters across the United States and Canada have gone missing or have fallen victim to violence.

Many have been murdered or remain missing to this day. In fact, in the United States, Indigenous women are more than twice as likely to experience violence than any other demographic. Nya:wëh for gathering with us as one community to raise awareness for those Indigenous women taken from their families, their homes and their communities. Nya:wëh for showing your support in the on going fight to protect Native people everywhere," shared President Matthew B. Pagels.



"Skirts of Unity" were worn during the social as the community came together as one. "The skirts were hand crafted and traded as a joint healing effort from five different Nations

safe," explains Sharon Francis, Program Coordinator, Crime Victims Services.

MMIW began as a grassroots effort due to the high rates of missing and murdered women of Turtle Island. This movement brings awareness to the many missing mothers, daughters, sisters, nieces, cousins and friends that didn't make it home and hopes to end violence against Indigenous women.

As Hodinöshö:ni' people, we are a matrilineal society and it is our tradition beginning with the Creation Story and Sky Woman, to honor women as sacred beings and life givers. Women are the heart and soul of our communities; they provide life, love, education, warmth and of course laughter. They form our identity early on from a long line of strong resilient ancestors.

Red is a powerful color, and is worn by the movement to bring attention to the crisis of Missing and Murdered Indigenous Women. Red shirts were given to participants that danced in the social. Music was provided

throughout Hodinöshö:ni Territory. The Tonawanda Seneca Nation, the Tuscarora Nation, the Onondaga Nation, the Mohawk Nation - Akwesasne Territory and the Seneca Nation of Indians came together in a show of unity, solidarity and support. We are in this fight together to keep our women

POLICY INITIATIVES AND LANDMARKS

May 5, 2019 - The White House proclamation officially designated as the National Day of Awareness for Missing and Murdered Native Women and Girls.

2019 - Executive Order 13898, a/k/a Operation Lady Justice, creates a task force for missing

and murdered AI/AN peoples that will address the concerns of Indigenous communities in the U.S., such as data collection, policies, establish cold-case teams, and improve investigative responses.

2020 - Savanna's Act became law and requires the Department of Justice to review, revise and develop policies and protocols to

address MMIP cases.

2021 - Secretary of the Interior Deb Haaland (Laguna Pueblo) announced the formation of the Missing and Murdered Unit that will focus on analyzing and solving missing and murdered Indigenous peoples (MMIP) cases.

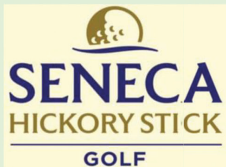

Common Ground Health launching listening tour w/ Indigenous Populations

The COVID-19 pandemic didn't create health disparities, it simply laid bare those that were already existing, Dr. Anthony Fauci, the federal COVID response architect is famously quoted as saying.

It also made plain for public health workers where they lacked relationships and collaboration.

As Common Ground Health worked to reach out to populations in 2021 to share work about COVID vaccines, staff found there were groups living locally with whom they didn't have existing relationships. For instance, they didn't have any leaders of local Indigenous communities in their databases and no Indigenous community representatives were taking part in existing coalitions and workgroups.

In assembling a group of Indigenous professionals to help inform and guide outreach, Common Ground staff began identifying how much they didn't know about health outcomes of people indigenous to the land that now makes up the United States. Staff also learned about some of the historical traumas experienced by Indigenous populations from government agencies through boarding schools, forced relocations and forced sterilizations, to name a few. It became clear that more work

to address Indigenous health disparities locally needed to be done, outside of the initial focus on COVID-19.

For instance, during the first 7 months of the COVID-19 pandemic, Indigenous populations were sickened with COVID at 3.5 times the rate of Whites, according to the Centers for Disease Control and Prevention. But locally, statistics on Native populations during the pandemic have been hard to find due to a lack of data and reporting stemming from a lack of systems to accurately account for this information.

In response, several local Native advocates have generously given their time to help improve collaboration and address the needs of Native populations. Next the group will be taking part in a listening tour, where they will interview local Indigenous stakeholders and residents to better understand the factors affecting Indigenous health outcomes in the Finger Lakes region. Long term, the advocates have called for the launch of an Indigenous Health Coalition if there is interest from local Native populations.

"At the very least, this work is overdue," said Native advocate Ronalyn Pollack, CHHC, AADP (Mississaugas of the Credit First Nation/Six Nations of the Grand River). Pollack, along with

Common Ground Health launching listening tour w/Indigenous Populations - CONTINUED

Dean Seneca, MPH, MCURP, (Seneca) CEO and founder of Seneca Scientific Solutions, and Todd Michel Waite, BA, MA (Seneca), Program Officer at Max and Marian Farash Charitable Foundation, have been advising Common Ground in its outreach with Native populations. They also served as panelists for an Indigenous forum around the COVID vaccines.

Common Ground Health is seeking input from the Indigenous community in the development of the forthcoming survey to update the 2018 My Health Story survey; community members are reviewing questions for cultural appropriateness and relevance.

The advocates note that the work will not just be specific to the Haudenosaunee people, (who are the original residents of the Finger Lakes region) but will encompass all people with Indigenous heritage who are living in the area.

“We are reaching out to find

those Indigenous people living throughout the community who are interested in improving the health of Indigenous families in the community,” Seneca said.

Dean Seneca is uniquely qualified to advance this work; he previously was a senior health scientist at the CDC’s Center for State, Tribal, Local and Territorial Support and he is an adjunct professor of the SUNY University at Buffalo’s School of Public Health and Health Professions where he teaches a course on Indigenous health disparities. In addition to being part of the team of advocates leading the work, Seneca is serving in a consulting role with Common Ground Health to identify available data sets that can shed light on Indigenous health. Seneca also provided a training on Indigenous health disparities to Common Ground’s staff in June of 2021.

A big part of the work is building trust by following through with commitments, the Indigenous advocates say.

“This comes with humbleness,” Waite said. “It’s by us for us. Common Ground is there as a willing partner to help grow this.”

“So many times throughout history, similar initiatives have been promised, and then do not come to fruition. Building trust with and learning from our local Native communities is our top priority,” said Hannah Shippee, a program coordinator with Common Ground Health, who has been the organization’s key liaison with the Indigenous community. She noted that Common Ground is committed to maintaining relationships for the long term, and understands how important listening to Indigenous families’ experiences and recommendations for change will be to informing this work.

The group also hopes to reach out to the more than 13,000 people with Native heritage who live in the Finger Lakes region, the majority of which live in Monroe County. The goal of the work is to make the Indigenous

community visible to ensure it isn’t left behind or forgotten by others. The advocates also note that traditional ways can and must be an asset to the movement towards health equity, including rediscovering language, cultural practices and traditions that lead to healing.

Common Ground officials say they are committed to supporting these efforts long term.

“Common Ground is committed to learning from and walking alongside the Native peoples, so we can leverage Common Ground’s expertise in collaboration, alongside the cultural expertise of our Native partners, to support them in achieving the best health outcomes possible,” said Wade Norwood, CEO of Common Ground Health.

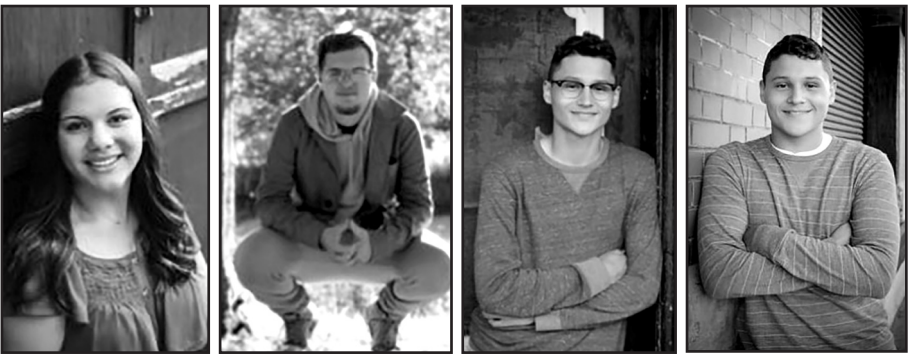

Statement By Mothers of The Seneca Nation

In Support of National Missing and Murdered Indigenous Women Awareness Day

(CATTARAUGUS TERRITORY, Irving, NY, May 5, 2022) — Today the Mothers of the Seneca Nation stand in solidarity, and express support, of the national day of awareness for Missing and Murdered Indigenous Women. President Joe Biden signed a proclamation declaring May 5, 2022 as Missing or Murdered Indigenous Persons Awareness Day.

On the Cattaraugus territory, Seneca community members, including the Mothers of the Nation, are gathering for a “Skirts for Unity Day” event, where women and girls will be wearing red. Red graphically signifies the blood of assaulted and murdered indigenous women.

In the late summer of 2021,

the case of a missing young, attractive white woman, Gabby Petito captured the headlines almost daily for weeks. A detailed timeline of the case was posted by CNN, from the time Petito embarked on her fatal cross-country trip, to her disappearance, and then the subsequent discovery of her fiancée’s body and journal—in which he confessed to her murder.

The case generated widespread media attention and sparked criticism from Natives, and other minority communities, about the disparities in coverage of cases involving missing brown and black women. The wall-to-wall breaking news coverage of Petito displayed the comparative lack of value attributed to missing indigenous

women and girls.

Figures from the Department of Justice reports on violence against Native women are jarring: American Indian and Alaska Native Women experience higher rates of domestic violence and sexual assault than any other population of women in the U.S. Further statistics indicate that Native women are stalked and murdered at higher rates than all other populations of women in the country. Four out of five Native women experience some form of violence in their lifetime; and Native women face murder rates more than 10 times the national average. Homicide is the third leading cause of death among Native women and girls ages 10-24.

Today the Missing and Murdered Indigenous Women and Girls (MMIWG) movement seeks to prevent girls from going missing with education efforts and to hold the justice system accountable.

The Mothers of the Nation contend that part of the problem has to do with the intentional erasure of indigenous peoples, their voices, stories and narratives.

The Mothers of the Nation are dedicated to actively defending the Nation’s sovereignty, protecting the Nation’s assets and resources— including, and especially, the life and livelihoods of Seneca women, the very life givers and perpetuators of the Seneca people and our future.
