update, we continue to have an elevated number of COVID cases on both Territories. Please continue to get vaccinations and boosters to protect our community. While breakthrough cases occur, the symptoms are much less severe with the vaccination.



### Greetings,

I'd like to say an early Happy Father's Day to all of our fathers, grandfathers, uncles and mother's doing double duty. Being a father, a grandfather and a great-grandfather has been one of the most rewarding privileges I've had. Check the SNI website at sni.org for information about all of the upcoming events planned for celebrating Father's Day.

If you've been outside

in the past couple of weeks, chances are you've been the victim of the gypsy moth caterpillars. Technically they don't bite, but the tiny hairs can cause a reaction on human skin which resembles a red bug bite. You've probably also seen the helicopters flying low over the territories. They are providing a treatment for the gypsy moth caterpillars to reduce the amount of damage they inflict on the surrounding foliage. I heard they were so bad last year - you could hear them chewing up the leaves on the trees. We're hopeful the spraying will help to control them.

The National Lacrosse League (NLL), which is currently comprised of fifteen franchises from the U.S. and Canada, was founded in 1986 and is hailed as the premier world professional lacrosse league. The playoff season for the 2022 NLL Cup, which began in early May, is the first finals to be played since the 2018-19 season. Playing in the 2022 east meets west finals, are the Buffalo Bandits, who finished their regular season with a 14-4 league best record and won their last NLL Cup in 2008 versus the Colorado Mammoth, who won their last NLL Cup in 2006. On June 4th, in the east meets west NLL finals, the Buffalo Bandits and the Colorado Mammoth squared off in game number one, at Buffalo. Even more exciting for all of us - we had two Senecas to root for! Frankie Brown from the Allegany Territory plays for the Buffalo Bandits and Zed Williams from the Cattaraugus Territory, plays

for the Colorado Mammoth. When it's all said and done, I know only one team will come out on top, but I was still rooting for both Seneca players! The Buffalo Bandits won game one with a score of fifteen to fourteen and the contest will continue on Saturday, June 11th, in Denver, CO.

In some lacrosse news even closer to home, I'd like to congratulate the Salamanca Warriors Varsity Boys for playing hard all season and making it to the Class D Championship game. The Warriors faced off against the Akron Tigers on June 1st, in West Seneca. In the second quarter, Salamanca had a five goal run, creating an 11-6 lead. They played their hearts out in the rain, but Akron took the win with a 22-18 victory. The team has two attackmen whom are Seniors and will be leaving the team soon, continuing on with their higher education goals. Austin Maybee had 65 goals, 19 assists, with 84 total points; while Tre Turner had 47 goals, 28 assists and 75 total points. Both have lacrosse commitments at their respective colleges. I'm very proud of our Salamanca Varsity Boys Lacrosse program and the hard work they continue to display each season!

Our area schools will be getting out soon for the summer break and it will be time for our Summer Recreation programs to begin.

## Seneca Nation and Dreamcatcher Foundation Host Bike Rodeo and Giveaway

The Seneca Nation partnered with Dreamcatcher Foundation to host a youth bike rodeo and safety fair at the Cattaraugus Community Center on May 25th and at the Allegany Community Center on May 26th. The Dream Catcher Foundation donated 100 youth bicycles (50 for each territory) in an effort to give back to Indigenous communities. The Seneca Nation Council Office purchased 100 helmets to go with the bikes to ensure safety. It was a great turn out with all bikes distributed to elementary-school-aged children.

The Dream Catcher Foundation was launched by professional racing cyclist Shayna Powless, Oneida, and her fiancé, professional football player for the Buffalo Bills Eli Ankou, Ojibwe. The Dream Catcher Foundation is committed to impacting the women and children of





Native American communities by providing resources and advocacy for Missing and Murdered Indigenous Women (MMIW). Their advocacy programs are intended to bring awareness to the fight against human trafficking and violence. The foundation is also an advocate for Indigenous youth programs. The Dream Catcher Foundation is part of Athletes + Causes, an umbrella for nonprofits that is based out of Florida.

The Seneca Nation Education Department facilitated the giveaway and the Allegany Education Department donated 12 additional bikes for pre-school aged children. The Allegany Marshals set up the bike course at the ACC complete with cones, obstacles and traffic rules. Shay Smith, Allegany Marshal, guided the children through the course and instructed them on the importance of safety on the road.

Likewise, the Cattaraugus Marshals created the course at the CCC and coordinated safety for that event. Seneca One Stop convenience stores donated the Chiavetta's chicken dinners for the public. Bike enthusiast Joe Thompson was on hand for manual checks and the Skatepark Project fundraiser group was on site at the ACC with an information table and donation jar.

Regarding the events, Councillor Josh Jimerson noted that "It was genuinely nice to see the kids smile and be happy. I want to thank everyone who helped make these events a success." Councillor Jimerson also acknowledged the generosity of Eli Ankou and Shayna Powless: "We as a community need to recognize Eli and Shayna for their efforts. They did say that they would like to continue working with the Seneca Nation in the future."



## **Seneca Nation Engages In Information Campaign With Native Nations And State Legislators**



Seneca Nation Councillors recently have been engaging in an information campaign to garner support from Native Nations, as well as from New York State legislators, to ensure that the state engages in good faith compact negotiations pursuant to the Indian Gaming Regulatory Act.

Affiliated Tribes of Northwest Indians (ATNI) Convention: In mid-May, Councillors William Canella and Presley Redeye, along with President Pagels, attended the ATNI 2022 Mid-Year Convention in Ferndale, Washington, where they explained the Nation's

recent conflicts with New York State over gaming issues. ATNI membership received our Nation officials favorably and passed a resolution that reads, in part, as follows:

WHEREAS, the Seneca Nation must now dialogue with [New York] state to obtain a new or amended gaming compact by December 2023, but is concerned that in light of the recent history between the parties, the state may not negotiate in good faith; and WHEREAS, the Seneca Nation may need assistance from the Department of the Interior in order to take the state to court for a determination regarding the state's lack of good faith negotiations; and

WHEREAS, a state should not be able to use its Eleventh Amendment immunity to violate IGRA without any recourse available to Native Nations; now

THEREFORE BE IT
RESOLVED, that ATNI
demands that states negotiate
in good faith with Native
Nations for new or amended
gaming compacts, as required
by IGRA; and

BE IT FURTHER RESOLVED,

that the Department of the Interior establish guidance that can be used by Native Nations as a resource for establishing whether a state is acting in bad faith; and

BE IT FINALLY RESOLVED, to the extent that states fail to negotiate in good faith, ATNI urges the federal government



to work with Native Nations to ensure that Native Nations are able to continue to engage in class III gaming activities consistent with IGRA.

## The 2022 Reservation Economic Summit (RES)

Councillors Angie Kennedy and Presley Redeye were speakers on the Federal Legislative Policy panel at RES on May 24th. They spoke on the Seneca Nation gaming compact issues, informing many Native Nation leaders of the Seneca Nation's compact struggles with New York State. Councillor Redeye provided the background of the issue and events leading up

to today. Councillor Kennedy urged tribal leadership in attendance to submit their comments on the draft Part 293 Class III Tribal State Gaming Compact regulations by the June 30th deadline. Councillor Kennedy informed the audience, "The Seneca Nation is not the only Native Nation struggling with Interior's existing regulations governing gaming compacts. You don't realize how important the regulations are until you run into a problem or fight with the State."

Councillors Arlene Bova, Eliot Jimerson and Robert Jones were also in attendance at RES. They attended numerous panels that would help the Seneca Nation make connections to business opportunities and expand its potential market.

### <u>Albany Meetings with State</u> <u>Legislators</u>

On May 24th, Councillors
Tina Abrams, Ross John, Tim
Waterman, and Josh Jimerson
had meetings in Albany with
Sen. Joe Addabbo, Sen. Sean
Ryan, Assembly Majority
Leader Crystal Peoples-Stokes,
and Assemblyman Gary
Pretlow. The Council also met
with the Assembly Republican
Conference (including
Assemblymen Joe Giglio, Angelo

Morinello and Andy Goodell) and with the Senate Republican Conference (including Senators George Borello, Rob Ortt and Pat Gallivan). During their meetings, the Councillors stressed the Seneca Nation's massive economic impact on the western New York region, as well as the rest of the state. Gaming compact issues also were discussed including the requirement that New York negotiate a new or amended compact in good faith. Additionally, Councillors raised the subject of treaty hunting and fishing rights.

## Pride flags raised in Cattaraugus & Allegany In honor of Pride Month

#PrideMonth is celebrated the month of June in honor of the Stonewall Uprising in Manhattan, recognized as the birth of the **Gay Liberation** Movement The LGBTQ+ community has faced historical discrimination and violence, and #Pride is a way to counter the narrative of oppression while also continuing to educate and advocate.



Last year, in 2021, a record 26 bills that were identified as anti-LGBTQ+ were enacted into law across ten states. In 2022, at least 320 anti-LGBTQ+ bills are already pending in state legislatures, more than half of which specifically target transgender youth and ban them from being able to fully participate in everyday life.

The Seneca Nation recently passed a resolution to recognize #PrideMonth and reaffirm the rights of our LGBTQ+ community members. Discrimination is intolerable, and it is our duty to embrace and uplift each other as Seneca people. To kick off #PrideMonth, Seneca Nation Leadership and community members gathered across the territories to raise the Pride flag.







### **Memorial Day Warrior Tribute 2022**

On Monday May 30, 2022, the Iroquois Post 1587 & Auxiliary along with the Seneca Nation, co-hosted a Memorial Day tribute in recognition to Warriors who paid the ultimate sacrifice at the Seneca Allegany Administration Building fallen warrior outdoor monument.

The tribute began with ringing the "Bells of Peace" by Iroquois Post 1587 Auxiliary member Julie Snow. Post Commander, Ron Cook Jr. (US Army Veteran) and master of ceremonies, introduced Al George (US Army Veteran) who gave the Thanksgiving Address along with an opening prayer by Post Chaplain Marvin Abrams (USMC Veteran). Post Commander Cook welcomed everyone and words of deep gratitude was given to support the observance of our fallen Warriors by Seneca Nation Treasurer Rickey L. Armstrong Sr. (US Air Force Veteran). Post Auxiliary member Julie Snow conducted a Roll Call of the fallen as Al George tolled the drum for each Warrior named.

The Seneca Nation Treasurer Rickey L. Armstrong Sr. along with Post Commander Ron Cook Jr. placed a wreath in solemn appreciation for the Warriors who paid the ultimate sacrifice followed by Post Auxiliary members Nadine Pierce and Sue Anne Gates with their wreath of gratitude. The customary 21-gun salute was executed by the Iroquois Post 1587 Honor Guard directed by Post Sgt@Arms Markey Jimerson (USMC Veteran) and TAPS played by Post Adjutant Annette Repicci (US Navy Veteran), which concluded the outdoor tribute.

The Warrior Tribute resumed



indoors with a Flag Song by
Al George and posting of the
Colors by the Iroquois Post
1587 Color Guard Team. Patrice
(Beck) Neyman of the Beaver
Clan gave an excellent rendition
of the Canadian and National
Anthems, which transitioned
into honoring this year's fallen
warriors Tech Sergeant Harold
E. Rogers (US Army Air Corps
WWII), PFC Leland Laye (US
Army Paratrooper WWII), and
Specialist Timothy P. Jones (US
Army Vietnam War Veteran).

On behalf of fallen warrior
Timothy P. Jones, a special eagle
feather heirloom along with a
Vietnam War Commemoration
Certificate with label pin was
presented to Jared Jones by
Seneca Nation Tribal Councilor
Tina Abrams. Closing remarks
were presented by Post
Commander Ron Cook Jr. and
Al George sang a Veteran's Song
to close out the tribute as the
Iroquois Post 1587 Color Guard
Team retired the Colors.

In addition, Post member Jennifer Helie (US Air Force Veteran) from the Veteran One-Stop Center of WNY provided an informational resource table and made herself available to answer any Service Officer questions. A delicious lunch was catered and all remaining packaged meals were delivered by Post Commander Cook and Post Judge Advocate Bella Cook to local Veterans in Allegany and Steamburg.

This annual event gives the Seneca Nation an opportunity to pay tribute to our fallen Warriors and share brief biographies read by Post Judge Advocate Bella Cook (US Army Veteran), Post Treasurer Josette "Nini" Wheeler (US Air Force Veteran), and Post Commander Cook respectively for Tech Sergeant Harold E. Rogers, PFC Leland Laye, and Specialist Timothy P. Jones.



Tech-Sgt Harold E. Rogers

Tech-Sgt Harold E. Rogers joined the Army Air Force in May 1942 and would receive orders to be forward deployed with the 8th Army Air Force in England and assigned as a tail gunner on a B-17 Flying Fortress Heavy Bomber aircraft, which was very effective during World War II as strategic bomber of German industrial targets. He would be accompanied by his dog "Mister" a half Chow and half Police dog mascot companion. After completing Opver 25 bombing missions with

one emergency bailout in the North Sea, Tech-Sgt Rogers would return state-side and would be assigned to perform instructor duties.

By June 1944, Tech-Sgt Rogers received orders to return to Europe with the 15th Army Air Corps in Italy without his mascot companion "Mister." He would be assigned to conduct combat operations with the 456th Bombardment Group, 744th Bombardment Squadron unofficially known as the "Steed's Flying Colts" in support of wartime efforts against the Germans.

On July 2nd, 1944 after conducting a bombing mission over German-occupied Hungary, Tech-Sgt Rogers' B-24 plane came under attack by several German Focke-Wulf FW190 (nicknamed: Wurger/ Shrike-Bird - Butcherbird) fighter planes when his plane became critically disabled. After making an assessing of the aircraft's condition, the uninjured crew members agreed to conduct an emergency bailout knowing that the aircraft would not make it back to home-base in Italy.

As agreed upon, the uninjured crew members executed bailout procedures and left the aircraft while uninjured Tech-Sgt Rogers without fear of own safety decided to stay back with his wounded crew members and a few moments after the emergency bailout the plane exploded in mid-air. Tech-Sgt Rogers would be awarded the Distinguished Flying Cross Medal for his heroic actions to remain in the disabled B-24 Liberator aircraft to care for the wounded crew members despite the dire combat situation. Tech-Sgt Rogers other awards and decorations include the Air Medal with nine oak leaf clusters, Distinguished Service Cross, and later posthumously awarded the Purple Heart medal by the President of the United States. Honoring Tech-Sergeant Harold E. Rogers killed in action July 02, 1944 who paid the Ultimate Sacrifice.

Private First Class (PFC) Leland Laye: Seneca from the Cattaraugus Territory served in the U.S. Army was born on July 4, 1918 in New York. His

parents Percival and Glennie were also both born in New York. They were both Seneca form the Cattaraugus Territory. His father worked as a farmer. Leland had one older brother named Harlan. Their mother died in 1920. The two brothers were raised on their maternal grandfather's farm, cared for by their mother's sister. Their father remarried and had four more children. It appears he passed away in 1939. By 1940 Leland had completed one year of high school and was living with his grandfather while working as a laborer. His older brother Harlen was also still living at home after completing four years of high school.

Leland was drafted into the U.S. Army on March 07, 1942. After Basic Infantry Training, he volunteered for airborne training and became a U.S. paratrooper and was promoted to Private First Class. He received follow-on orders assigned to Company H, 3rd Battalion, 505th Parachute Infantry Regiment, 82nd Airborne Division.

Leland deployed to North Africa and would make a combat airborne parachute jump into Sicily with the 505th Airborne Regiment on the night of July 10th, 1943, in support of wartime operations against the Germans in the European theater. He and Corporal Warren "Pappy" Lyons were assigned as a Bazooka "Tank Killer" Team were engaged in heavy fighting, which ensued throughout the night and into the next day where PFC Leland Laye along with CPL Lyons were killed in action when they moved ahead of their unit to engage a German Mark VI Tiger tank in heavy combat operations near Ponte Dirillo, Sicily. By the end of July 11, 1943, the paratroopers of the 3rd Battalion, 505th Infantry Regiment, 82nd Airborne

Division were able to push the German tank forces from the Biazza Ridge. A monument with Leland's name along with 38 other paratroopers' names still stands today in Ponte Dirillo, Sicily in recognition for the "Heroism and from the sacrifice of these men has created the new history of Europe." Leland posthumously received the Silver Star for his heroic actions and his Citation reads...

"The President of the United States of America, authorized by Act of Congress July 9, 1918, takes pride in presenting the Silver Star (Posthumously) to Private First Class Leland Laye (ASN: 32252291), United States Army, for gallantry in action while serving with Company H, 3d Battalion, 505th Parachute Infantry Regiment, 82d Airborne Division, in action on 11 July 1943, five miles west of (Ponte Dirillo)\*\*\*\*\*, Sicily. Private First Class Laye placed his rocket launcher in a position of vantage well in advance of his own forces. Although exposed to heavy enemy fire and regardless of the ineffectiveness of his own rocket fire, Private First Class Laye held his position and continued to operate his launcher against a Mark (VI Tiger I) \*\* \*\*\*\* tank until the tank, at a distance of fifty feet, fired its 88-mm main turret gun and killed him. His gallant actions and dedicated devotion to duty, without regard for his own life, were in keeping with the highest traditions of military service and reflect great credit upon himself and the United States Army."

Honoring our fallen Warrior PFC Leland Laye killed in action July 11, 1943 who paid the Ultimate Sacrifice.



Specialist Timothy Jones

Specialist Timothy Paul Jones born August 27, 1947, enrolled



member of the Seneca Nation of Indians and of the Turtle Clan. Timothy grew up on the Allegany Territory and struggled with completing formal education but knew the importance and acknowledging his responsibility of becoming a productive member of his community. Timothy received a draft notification and was inducted on April 25, 1967 to join the U.S. Armed Forces in support of escalating War efforts in Southeast Asia in the Republic of Vietnam. Timothy reported to the Military **Entrance Processing Station** (MEPS) in Buffalo, NY and sent to Basic Training and received advanced Infantry Training.

Shortly after Infantry training, Timothy received orders to deploy to Southeast Asia and would be assigned to Bravo Company, 2nd Battalion, 39th Infantry, 9th Infantry Division in support of the War efforts in the Republic of Vietnam. Timothy's unit had a prestigious history and were nicknamed the "OLD RELIABLES" first established during WWII. However, the North Vietnamese enemy forces quickly viewed them as fearless warriors as they conducted numerous combat missions from the Mekong Delta to the DMZ bringing intense bloody fighting capabilities and decimated their foes at each major engagement. These engagements included numerous victories over Main Force Viet Cong and North Vietnamese units with a lethal rapid deployment Mobile Riverine Force and with an Airmobile (helicopter) Calvary capability.

Tim's unit was prepared for a new kind of war, where U.S. helicopter gunships dominated the air transport corridors and used heavily armored assault boats with a multitude of diversified fire power platforms to pursue the enemy in remote ground and water hideaways. His mission was to assist the South Vietnamese military from the communist pacification effort who were trying to endorse the independence and sovereignty of the South Vietnamese government. Timothy would completed his draft service obligation and was honorably discharged on April 25, 1969 and returned home to the Allegany Territory.

Timothy's awards and decorations are many and commendable to name a few: Purple Heart; Warriors Medal of Valor; Combat Infantry Badge: National Defense Service Medal Vietnam War Service Medal; Republic of Vietnam Campaign Medal w/60 device Unit Republic of Vietnam Gallantry Cross Medal; Republic of Vietnam Civil Actions Medal Timothy Jones was a dedicated member of American Legion Iroquois Post 1587 for 27-years. Honoring our fallen Warrior SPC Timothy P. Jones who past away unexpectedly at the age of 74 due to health related complications.

The Seneca Nation of Indians and Iroquois Post 1587 would like to thank everyone who volunteered to decorate Veteran graves with flags on both Territories and to everyone who join the Memorial Day Warrior Tribute in Allegany.

The Seneca Nation and Iroquois Post 1587 paid tribute and honored our fallen warriors for their dedicated service to our Nation and for their bold and fearless actions during time of War exemplifies them as admired Warriors and Hero's. May our Warriors rest-in-peace. Dwa dë nök skö' (We are all related or connected)





## Seneca Nation, Roswell Park highlight importance of early cancer screenings | May 10, 2022 | spectrumlocalnews.com

Lafayette Williams, 58, lives on the Seneca Nation of Indians Cattaraugus Territory in Gowanda and enjoys spending time with his aunt, a long-time breast cancer survivor.

Williams has undergone a number of cancer screenings, including on his lungs, as he has been a smoker off and on for 48 years, and averaged about a pack a day.

"Coughing up gray phlegm and I said 'something's wrong, something's got to be going on here,' so I had to get it checked out," Williams said.

He's also been screened for colorectal cancer, but like many, he really didn't want to be.

"I was actually going through an anxiety attack at the office when my blood pressure ... shot up. Started realizing this is really happening, I'm really getting tested. It could be bad, I could have cancer," Williams said.

That is why Dr. Rodney Haring from the Center for Indigenous Cancer Research at Roswell Park in Buffalo encourages Native Americans to get screened and help reduce the impact cancer has on the high risk community.

"So, the survivorship from colorectal cancer and other cancers are better," Haring said. "The screening is really part of that medicine, screening is part of that innovation, and screening is really important in

finding the right mechanism to treat cancer."

Marissa Haring, a community patient navigator at the Center, helps guide those like Williams through the process, as well as provide support, and raise awareness about cancer prevention and screenings.

"So us being there to kind of bridge that gap between community members and cancer care centers is super (Continued on next page)

important," Haring said.

Haring also has an office at Native Pride in Irving, home of the J.C. Seneca Foundation, celebrating its 10th anniversary.

"Kind of goes pretty quickly,"
J.C. Seneca, J.C. Seneca
Foundation president, said.
"We've been able to do a lot
of different things to help our
community and surrounding
communities around our
territory."

One of those things was a good health initiative in March that focused on the importance of colorectal and other screenings, with an emphasis on listening to the body, much like the message to Seneca after suffering a recent heart problem.

"Sometimes things go on within our bodies that we kind of ignore or we don't pay attention to. Or we say is something else. But we need to listen to those things and get checked out," Seneca adds.

Williams' colonoscopy and lung screening came back negative.

"Really grateful to all of them," Williams said. "I was relieved and then it really made me think about stopping, cutting down on smoking."

He is down to about two cigarettes a day, a move he says makes him feel better than ever.

"Raking leaves or shoveling snow, I was running out of breath," Williams said. "I can see myself now breathing better and actually want to start exercising."

Frank Brown's first reaction when he found out he got traded to the Buffalo Bandits? Just let the energy and excitement take over you.

"The GM from Rochester, Dan Carey, he called me up and said that he traded me to Buffalo," Brown said. "You never want to hear that you got traded, so obviously that kind of made me feel a certain kind of way. But at the same time, when he finished the sentence and said he was sending me to Buffalo, it was like this jolt of pure joy. The second I got off the phone, I just started running around the house kind of like a little kid."

Connor Fields understands that feeling. Like Brown, he also grew up in Western New York. He was out on the golf course with his brother and fiancé when he got the call that he'd been traded to Buffalo.

"When I got the call, they said,
'You've got your wish, we traded
you back home," said Fields,
from the nearby suburb of East
Amherst. "I was like, 'Back home?

Bandits.' ... I couldn't have asked

past. To be able to be on a team that is playing in the Finals, you can't say much more than a dream come true."

Brown arrived in Buffalo first, coming over from Rochester on Feb. 27, 2020. The Red House, New York, native played two games in his first go-around with the Bandits before the COVID-19 pandemic shut down the season.

A canceled 2021 season and lingering injuries to start this year meant he had to wait until March 31 to get back out on the floor.

"At the beginning of the season, I kind of told myself, 'You're either going to get back to 100 percent, or you're never going to play again," Brown said. "It was just so frustrating, being a half-step behind here or there. Seeing plays that I know I could make had my

body been the way it should be and not being able to make them. It just got to a point where it wasn't that fun for me. Thankfully, [head coach John Tavares] and [GM Steve Dietrich] were patient with me all year."

He got back to full health, snagging 10 loose balls and causing four turnovers in four regular season games. He's recorded 15 loosies so far this postseason.

Fields and Brown understand the type of atmosphere they'll be walking into during the NLL Finals. Both were in attendance as teenaged fans the last time the Bandits won a championship, when Buffalo defeated the Portland LumberJax in 2008.

"One of the more mesmerizing goals that I've seen in my life was in that '08 game," Brown said.

"Cory Bomberry shot a low-to-high near side. Whoever the goalie was kind of baited him there, and Cory just blew it right by him."

Brown hopes he can now make the impact on the next generation that talents like Bomberry had on him. As a kid, he looked at the Native American players on the Bandits and felt validation, understanding that some day that could be him,

No matter who wins this year's NLL Finals, Native American kids from Western New York will have a champion to look up to. On the other bench will be Zed Williams, Brown's former teammate at Silver Creek High School.

"Zeddy and I are pretty active within our respective communities, him being from Cattaraugus and me being from Allegheny," Brown said. "Looking back to providing an example to the next generation of 'I can do that,' I think this is a really cool time for our communities. Everybody wins because somebody from our home is going to win an NLL championship. It's just another reason why all of this is pretty special."

Brown, of course, hopes he'll be the one lifting hardware this month. Just two wins stand between both hometown kids and the cherry on top of a dream come true.

"For field lacrosse, I always thought about college, a national championship," Fields said. "But for box lacrosse, I always thought of playing for the Bandits. That was probably my biggest goal, and winning a championship for Buffalo,"



## What's the best age to start receiving retirement

**benefits?** Submitted by Briana Snyder, AOA Options Counselor

The answer is that there's not a single "best" age for everyone and, ultimately, it's your choice. The most important thing is to make an informed decision. Base your decision about when to apply for benefits on your individual and family circumstances. What you should know before you apply:

### What does "retirement" mean?

Retiring means getting your Social Security retirement benefit. It might mean that you've also stopped working. However, these two things don't need to happen at the same time. For example, you have the option of delaying your monthly benefit even after you stop working. Delaying your benefit will increase your monthly benefit amount. (See below.)

Your benefits are based on your entire earnings history Do you know how your benefit is calculated? Your monthly benefit amount is based on your highest 35 years of earnings. If you don't have 35 years of earnings, your monthly benefit will be reduced, because years with no earnings will count as zeros.

### Your monthly benefit is higher if you wait to start

When should you start your retirement benefit? You can start receiving benefits as early as age 62. However, the longer you wait (up to age 70), the higher your monthly benefit will be — for the rest of your life. If you're married and you're the higher earner, delaying your benefit may also mean higher survivor benefits for your spouse when you pass away.

### Your full retirement age may be higher than you think

Your "full retirement age" is determined by the year you were born. The retirement age used to be 65 for everyone, but is gradually increasing to 67. As the full retirement age goes up, benefits claimed at earlier ages go down.

Edible marijuana products can look just like regular sweets and snacks. These snacks often include:

Gummies, chocolate bars, hard candies, brownies and chips. These snacks are packaged to look very similar to real snacks. These can sometimes be considered "copycat" snacks, but they contain tetrahydrocannabinol (THC), that can far exceed the limits set by state cannabis regulations and standards. Recent attention is being drawn to these edible snacks because of this branding and imagery as being enticing to children. It has become a public health concern as many consumers including children have mistaken these snacks for normal snacks and accidently consumed them. From 2017 to 2019, US Poison Control Centers handled nearly 2,000 cases of young children accidently consuming these THC filled edibles. In 2020, the American Association of Poison Control Centers reported more than 3,000 exposures to edible marijuana products involving kids under age 12 in the United States. Many were children that were five years old and younger.

Despite their ordinary appearance, just one THC filled edible can contain several times the recommended adult dose of THC. If someone were to eat an entire edible the effects can be severe. That is why the dangers of this packaging is so dangerous to children. These overdose effects can include:

- Intoxication
- Paranoia
- Altered perception
- Dizziness
- Anxiety/Panic
- Slurred speech
- Weakness
- Sleepiness
- **Poor Coordination**

Edible THC products take longer to get into the system than if the person smokes the marijuana. The time it takes after eating an edible is usually 30 to 60 minutes and then peaks at about three to four hours after ingesting.

If you have edibles in your home:

- Store them safely -Keep your edibles out of the reach of children. They should be locked away and in child resistant packaging. Take them out of the "copycat" packaging and into something that isn't familiar or eye appealing to children.
- Use them with caution do not consume edibles in front of children under any circumstances. These products may be tempting for children. This may also be dangerous while caring for children as it could impair your ability to care for them.
- Avoid buying the edibles that are in copycat packaging - Always put them out of reach before and after use.

If your child eats a marijuana edible by accident, first find out what they ate and how much they consumed. Examine the wrapper to determine how much THC is contained in the edible. Call the poison control hotline 1-800-222-1222 as soon as possible for direct help.


Talk to your children about the potential harm of marijuana and THC filled edibles and the potential harm to their developing minds. Treat these talks the same way you would discuss the dangers of any other substances that are harmful

to kids. These include alcohol, tobacco use and prescription medications. Remind them never to drive under the influence of any substance including marijuana. Impaired driving is a dangerous situation for anyone and can result in fatal car crashes.

Most states that have legalized recreational cannabis limit the amount of THC in edibles for the most part from 5 mg to 10 mg of a THC dose and 100 mg prepackage. The reason these edibles are so concerning is that the packaging on the copycat edibles said they contained and average of 459 mg of THC and can range from 300 to 600 mg per package. What's more concerning is that this packaging does not include serving size or number of servings, therefore leaving it up to the consumer on how much they can eat without knowing the milligram size per serving. The study results were published recently in the journal **Drug and Alco**hol Dependence.

### **Counselor's Corner**

Counselor's Corner would like to introduce the CHWC's Behavioral Health Unit Supervisor (BHU), Allen Ward, LCSW-R. He is the Clinical Services Supervisor for the Cattaraugus Behavioral Health Unit located at CHWC. Allen attended Erie Community College for two years before transferring to Fredonia State College to pursue a B.A. degree in psychology. He took five years off after college to work at New Directions Youth and Family Services residential treatment facility and therapeutic foster care program. Six years later he enrolled at the University at Buffalo to pursue a Master's Degree in social work while also working full time at Lakeshore Hospital in the inpatient psychiatric unit. After graduation, Allen accepted an outpatient counseling position with SNHS Behavioral Health. Allen stated he had worked as a counselor for approximately 11 years, when an opportunity presented itself to become the Clinical Services Supervisor located at the Cattaraugus Behavioral Health Unit. Allen gladly accepted that position.

It was Allen's desire to become a counselor, because while attending Erie Community College, he recalls that he had a great interest in psychology after taking an abnormal psychology class. This really generated his passion for wanting to help people. Allen stated that he felt he was always a people person, so it seemed like a natural fit to pursue this career.

Allen believes that he was steered towards this occupation because his interests are specific to those with major mood and anxiety disorders. He likes working with couples and families as well. "My clinical specialty is DBT (Dialectal Behavior Therapy) and EMDR (Eye Movement Desensitization and Reprocessing) and enjoys working with people that may have these needs" Allen stated.

He feels that the most important attributes of a good counselor are to be an excellent listener, to be genuine, flexible and able to empathize with others.

Allen feels that the biggest challenge that counselors face today is that the need for counselors far exceeds the availability. "Coming out of the pandemic, we have seen a huge influx of people wanting men-

tal health counseling across the country and there is a shortage of therapists available to meet this real need", stated Allen. Another challenge is that because of the ratio of counselors to clients, it can lead to potential burnout for the counselor.

Allen feels that in order to be an effective worker and supervisor, daily self-care is essential. Even simple and small provisions can help. "I like to jog, walk and play guitar. I also enjoy just going on an adventure somewhere, traveling and watching a show on TV or a movie".

Allen stated that he likes his client to take the lead and teach him about the importance of their culture and then he will incorporate as much culture into treatment as they would like. He will actively encourage and engage them in their culture and spirituality to personalize their treatment.

How does Allen unwind during his down time? He is a certified scuba diver, he loves to downhill ski, and also enjoys eating diverse foods throughout the world. He especially likes spicy foods!


